RE: Assembly Bill 6809-B in relation to optional partial public financing of certain election campaigns.

I am responding to your request for information regarding Assembly Bill 6809-B (forwarded to you by Assembly Speaker Mel Miller) which would provide optional partial public financing of certain state election campaigns.

While Speaker Miller forwarded a correct copy of the bill adopted on February 22, 1988 by the Assembly, he inadvertently sent along an earlier drafted and now very incorrect memo in support. This memo spoke of the inclusion of the city council in the scope of the bill, when in fact the adopted Assembly bill only covered the offices of Governor, Lieutenant Governor, Attorney General, State Comptroller, State Senator and Assembly Member. The Assembly bill does provide for a locality with a population over 100,000 residents to adopt a resolution asking the State Legislature to enact an optional public financing law for that locality. But, nothing in the adopted Assembly bill

"shall be construed to diminish any authority of a county, city or town which existed on the date of the enactment of this section. Thus, the city's new campaign finance law would not be affected by the provisions of A.6809-B.

The Assembly bill, as it applies to elected state officials is similar to our bill in many of its terms and conditions. Some of the specifics of the bill are:

1) Contribution maximum to any non-statewide office (i.e. Mayor, Comptroller etc.) is reduced from a possible \$50,000 to \$5,000. This does not affect our bill which sets maximum contribution limits for opting in candidates of \$3,000. It would affect city candidates who do not opt in to our law and who are running for city-wide office.

3) The Assembly bill calls for a \$3 check off (\$6 for joint returns) on state tax returns to be transferred to the New York State Election Campaign Fund. A New York City tax

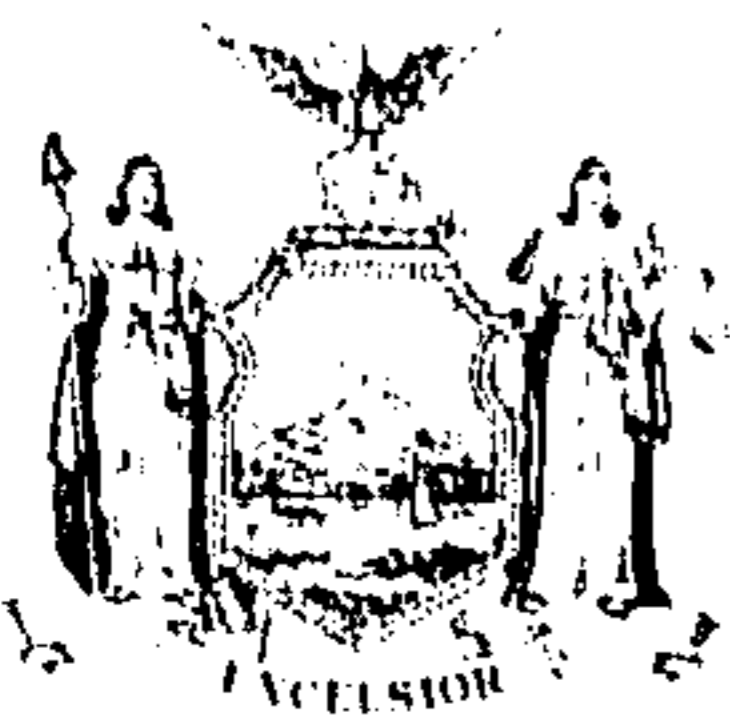

Dear Peter:

Thank you for contacting me to express your support for Assembly Bill 6809-B, which enacts the "Campaign Financing Reform Act of 1988" whereunder public funds are provided for the optional partial public financing of qualified candidates for certain State and local elective offices. I appreciate the time you have taken to share your views with me.

Under the Assembly's plan, each taxpayer would be asked to contribute \$3 of their State income tax refund starting this year to a special account. The money would finance races for Governor, Lieutenant Governor, Attorney General, and Comptroller starting in 1990, and for the State Legislature starting in 1992. The plan couples public funding for campaigns with new, lower limits on campaign spending, which range from a \$75,000 cap on Assembly races to \$7 million for a gubernatorial race. Also, the bill authorizes an income tax check-off provision of \$2 for N.Y. City taxpayers. } ✓

You will be very pleased to know that this bill passed the New York State Assembly on February 22nd and has now been delivered to the State Senate. Accordingly, I strongly urge you and the other City Council members to contact Senate Majority Leader Warren Anderson and your local Senators to inform them of your support for this very important measure.

Enclosed is a copy of our proposal and its accompanying memorandum for your review.

Introduced at the request of GOVERNOR'S PROGRAM BILL

Title of Bill: RE: AN ACT to amend the election law and the tax law, in relation to providing for optional partial public financing of certain election campaigns and to repeal subdivision three of section 14-114 of the election law relating thereto; and making an appropriation therefor

Purpose:

To provide optional public financing of campaigns for Statewide offices, State legislative offices, and the City of New York offices of Mayor, President of the City Council, Comptroller, Borough President and Member of the City Council; and to provide localities with a population over 100,000 with an option to request legislation for public financing of local campaigns.

Summary of Provisions:

The bill amends Article 14 of the Election Law to add a new Title II and Title III providing for public financing of primary and general election campaigns for Statewide office and State legislative office and for campaigns for New York City offices. It also adds a new Title IV to provide an option for localities to adopt public financing for local races. The principal components of the public financing scheme are outlined below.

1. Eligibility:

To be eligible for public financing, a candidate for nomination or election must satisfy the legal requirements for having his or her name on the ballot, elect to participate in the public financing system, file required statements and meet the threshold for eligibility.

The eligibility threshold in a primary or general election is as follows:

Governor -- Not less than \$225,000 in matchable contributions, including at least 1000 contributions in the amount of \$10 or more

Lt. Governor -- Not less than \$75,000 in matchable (primary only), contributions, including at least 500 Attorney General contributions of \$10 or more & Comptroller

- Senate -- Not less than \$5000 in matchable contributions,
including at least 25 contributions of \$10 or more
- Assembly -- Not less than \$2500 in matchable
contributions, including at least 25
contributions of \$10 or more
- NYC Mayor -- Not less than \$225,000 in matchable
contributions, including at least 1000
contributions of \$10 or more
- NYC City Council -- Not less than \$50,000 in matchable
President and contributions, including at least 500
Comptroller such contributions of \$10 or more
- NYC Borough -- Not less than 2 cents for each resident of
President borough, including 100 contributions of \$10
or more
- NYC Council -- Not less than \$5000 in matchable
Member contributions, including at least 25 such
contributions of \$10 or more

"Matchable contributions" consist of the net amount of contributions after deduction of the value of any food, drink or entertainment provided in exchange for the contribution. Only contributions from persons who reside in New York State are matchable.

Contributions are matched at the rate of \$1 for every \$1 dollar net contribution up to a maximum of \$500 for any one contribution. If, however, a candidate who does not elect to receive public funds spends more than one-half of the expenditure limit for such office, a publicly funded candidate for such office may receive \$2 for each \$1 in matchable contributions.

To receive public funds for a primary election, a candidate must agree to receive public funding for the general election. Candidates who are unopposed in a primary election may not receive public funds unless there is a contest in the primary for at least one other party for such office, in which event they shall be allowed up to 50 cents for each \$1 in matchable contributions. Candidates who are challenged in a primary and who do not seek public funds are not eligible for public funds for the general election, nor are candidates who are unopposed in a general or special election.

Public funds may be used only for expenditures during the calendar year of the primary or general election for services, material, facilities or other things of value used in that year. They may not be used for salaries or wages, payments in cash, or expenditures for food, drink or entertainment.

2. Contribution Limits:

The following contribution limits apply to all contributions for offices for which public funds are available.

Statewide	\$3,750
Assembly	\$1,250
Senate	\$1,250
NYC Mayor	\$3,750
NYC Council	\$3,750

Bor. Pres.	\$2,000
City Council	\$1,250

Under current law, the contribution limits are as follows:

Statewide Office - 1/2 cent per enrolled voter for prim. (approx. \$20,000) and 1/2 cent per reg. voter for general election (approx. \$40,000).

Other Offices -

- (1) 5 cents per enrolled voter for primary
- (2) 5 cents per reg. voter up to \$50,000 for general election OR up to \$4,000 for Senate and \$2,500 for Assembly, whichever is higher.

Candidates and their committees may not accept contributions earlier than one year before the first day for circulating designating petitions or later than the last day of the calendar year when the election is held, except to the extent necessary to satisfy a deficit.

For offices for which public funding is not available, the bill substantially reduces individual contribution limits to no more than 5 cents per enrolled voter in the district in a primary election or 5 cents per registered voter in a general election, but in no event more than \$5,000 or less than \$1,000.

3. Expenditure Limits:

The following expenditure limits apply to all candidates who receive public funding.

NYC Mayor	\$3,000,000	75 cents per EV or \$375,000, whichever is greater, but not more than \$2,250,000
NYC Council Pres. & Comptroller	\$1,000,000	75 cents per EV or \$375,000, whichever is greater, but not more than \$750,000
NYC Borough Pres.	\$ 650,000	75 cents per EV or \$75,000, whichever is greater, but not more than \$500,000
NYC Council Member	\$ 60,000	75 cents per EV or \$10,000, whichever is greater

If a candidate who does not accept public funding spends more than one-half the expenditure limit for such office, the expenditure limit for publicly funded candidates for such office is increased by one-third.

Candidates unopposed in a primary may spend one-half of the expenditure limit if there is one other contest for such office.

4. Tax Check-off:

The bill provides an income tax check-off provision of \$3 for New York State taxpayers and \$2 for New York City taxpayers. Such monies would be paid into separate funds, known as the New York State Election Campaign Fund and the New York City Election Campaign Fund, in the custody of the Commissioner of Taxation and Finance, for payment to candidates on the audit and warrant of the Comptroller on vouchers certified or approved by the New York State Board of Elections.

5. Penalties:

The bill provides that failure to file a statement or record required by Title II or Title III of Article 14 or implementing rules or regulations of the State Board shall be subject to a civil penalty of up to \$1,000 in a civil proceeding by the State Board. If such failure to file is knowing and willful, it is punishable as a Class A misdemeanor.

The bill also punishes as a Class A misdemeanor conduct by any person who knowingly and willfully violates the public campaign financing provisions or participates in contributions or expenditures which exceed legal maximums, fails to furnish required information or furnishes false information.

In addition, the bill provides that, if a candidate's aggregate expenditures exceed the expenditure limitations, the candidate is liable for a civil penalty in an amount equal to three times the amount of the excess.

6. Public Financing of Local Offices:

The bill authorizes the legislative body of a county, city or town with a population of more than 100,000 to adopt a resolution requesting the adoption of a public campaign financing law for local elections. Following adoption of such a resolution, public hearings on the proposal must be held and, not less than 90 days thereafter, a legislative proposal embodying the plan must be submitted to the State Legislature.

Existing Law:

Current law does not provide for public financing of any election campaigns and in the absence of such public funding, it is unconstitutional to limit aggregate campaign expenditures or personal expenditures by a candidate. While the law limits the amount of individual contributions, the current formulas permit large contributions.

Statement in Support:

This public campaign financing bill is identical to the bill that was negotiated with and approved by the Assembly in 1986. It provides a comprehensive public financing scheme with effective limitations on expenditures and contribution receipts.

This important measure will assist in assuring that campaigns are free from corruption, special privilege and unwarranted obligations, as well as from the appearance of such evils. It also will relieve eligible candidates of the onerous and time-consuming burden of raising private contributions and enable them to devote their time and efforts to a full exposition of the issues, thereby benefitting the voters of the State.

Budget Implications:

The bill appropriates \$375,000 to the State Board of Elections for the administration and implementation of the bill's provisions.






